1. Restricted stock units (RSUs) convert into common stock on a 1-for-1 basis. RSUs have no exercise price or expiration date.

2. On February 2, 2021, the reporting person was granted 3,827 RSUs, vesting in four equal annual installments beginning on the first anniversary of the grant date.

3. On January 22, 2025, the reporting person filed a Form 4 which inadvertently added LTIP units to his restricted stock unit total in Column 9. This Form 4 reflects the correct totals for each Column 9.

4. The rights to convert vested LTIP Units into Common Units and redeem Common Units have no expiration dates.
