DEUs and the underlying DSUs vest 100% on the earlier of the first anniversary of the grant date or the first anniversary and the trace of the prologis and the underlying DSUs. DSUs and DEUs are paid in the form of Prologis common stock at the rate of one common share per DSU or DEU. Balance in column 9 includes DSUs and DEUs.
